Application Information:

- **Space is reserved on a first come, first serve basis.**
- Once your application is approved, it will serve as your contractual agreement to participate in the 2021 Yard Sale event. All fees must be paid at the time you receive acceptance of your application from the Gainesville Area Chamber of Commerce Staff.
- This event is rain or shine. Outdoor vendors will be returned their fees if requested. Indoor vendor fees are non-refundable since the event will continue.
- Cancellations must be submitted via email no less than 10 days prior to the event to qualify for a refund.
- **Application deadline is Friday, May 21st by 5:00 PM**

Setup Information:

- Vendor set up is June 4th and June 5th from 5:30 AM - 7:30 AM. All spaces must be occupied by 7:30 AM or your spot will be forfeited with no refund. The Gainesville Area Chamber of Commerce, Cooke County Fair Association, nor the Cooke County 4H will be responsible for missing or stolen items. If you have a large vehicle or trailer to maneuver, please plan on arriving early.
- All materials must fit in your assigned vendor space.
- No vehicles will be allowed indoors.
- The sale of live animals, alcohol, guns / ammunition are NOT allowed.
- Trailers will be allowed to set up in the outdoor vendor spaces, but all vehicles must vacate the event area and move to vendor parking during the sale hours (8 AM - 5 PM).
- No dollies or carts will be provided, you will need to provide your own solution to bringing your items in and out of the arena.
- Vendors are responsible for bringing tables, chairs, tents, etc.
- No electricity will be available and generators are not allowed within the barn. Whisper generators may be used outside.
- Spaces are located on solid surface. Please plan to anchor items accordingly. No stakes or spikes allowed.
- Fresh water hookups will not be available.
- Booths must always have at least one person present.
- Vendors must operate their booth until 5:00 PM and cannot tear down until that time or you will not be allowed back next year.
- **Vendors are responsible for leaving their area in the condition that it was originally received in, i.e. removal of all debris such as boxes and trash. There will be no place for you to dispose of / dump unwanted items.**
NO items unsold can be left. You must take all unsold items with you.
